MINUTES

Summer Term Meeting 2025 Local Governing Board: Lew Trenchard & St Catherine's CofE School Hub Tuesday 1st July 2025 / midday at Central Office

1. Welcome (including Trust Identity) and Apologies

The Chair welcomed everyone and opened the meeting with a prayer by the Reverend Jane. GS introduced herself for the benefit of the recently appointed governors and offered to help wherever needed. LH briefly recapped the Trust Identity presentation, emphasising that our children leave the schools able to be good citizens.

2. Declarations of Interest relevant to this agenda

None were declared relevant to this meeting.

3. Governors

MY has tendered her resignation with effect from 23rd July 2025. The Chair thanked MY for her many years of service and GS thanked her on behalf of the Trust. JS resigned with effect from 11th May 2025.

The governors appointed Rev. Michael Dobson as a new Co-opted Governor in his absence. MD confirmed that he was happy to be appointed in absentia. He is the vicar of St Mary's in Launceston. TL agreed to be nominated as a Foundation Governor.

6. Confidential Matters

LH shared confidential financial matters which are recorded separately in Confidential Matters.

7. Heads' Reports

The Heads' Reports have been made available to all governors and the governors raised various concerns and challenges. Regarding the church vision (item 2:1 in the HoS Report), as Church of England schools why are you allowing "cultural changes in belief" to influence R.E? There should not be any embarrassment about being Christian. These are two separate elements. RE is a discreet academic subject and shouldn't be confused with the Church vision or ethos. We aren't compromising our Christianity. The R.E. syllabus covers different religions, including world views which covers those who have no religion. Regardless of what we believe, learning religion and cultural diversity is very important. St Catherine's Ofsted Inspectors were heavily focussed on how we teach cultural diversity. Our Christianity aspect is about teaching the Word of God and the stories of Jesus and how we can be good citizens by following the Bible. Worship and R.E. have to be kept completely separate. Why do we teach R.E? Because we are a diverse community now, and we need to learn about other cultures and religions. Has there been a monitoring visit for R.E? No, but this could be included in a SIAMS visit.

The Devon Mental Health Team are now rolling out their new service; have they made their school visit yet? They were due to visit Lew Trenchard and to meet Karl Jane (Y1 & Y2 Teacher) a few weeks ago but they rescheduled. It is worth pursuing their visit as they have been very helpful at St Catherine's.

Where it talks about racism in the HoS report, can you just give us a little more context on this please? And how it is mitigated for both Lew Trenchard & St Catherine's? Lew Trenchard figures look worse than it is, as we record absolutely everything. All instances have been satisfactorily dealt with, sometimes using whole class lessons to cover the instance whenever appropriate. Most of the diverse language has been picked up from songs that the children listen to. We are incorporating diversity within the R.E. curriculum.

How will Lew Trenchard keep the momentum going with the OPaL project after Dale Payton (Y5 &Y6 Teacher) leaves? Who will take over? LD explained that OPaL (Outdoor Play & Learning) employs a consultant who works with the school. LH has information that she can send to any interested governors. Lew Trenchard will still be running it and LD has asked staff to join in with this as it should be a team effort. The P.E. funding can be used to help with OpaL and DP will remain as the Trust Lead for P.E. The P.E. curriculum at Lew Trenchard is now in a very good place. TL has contacts with 'KICK' (who offer mentoring and sports coaching in schools). TL will enquire if they may be interested in helping to set up P.E. resources.

What is the impact of the Sustainability Centre please? How is it funded? The impact isn't known yet as there will be different responses from the Trust schools. The review process will be at Trust level. The purchase costs were shared amongst the Trust schools. Is this done fairly amongst all the Trust schools? Does everyone get equal access to it? Yes, but it is more difficult to implement with a larger school so there is variation in numbers of session dependent on class size. Is there a process for reviewing it? For instance Pupil Voice? The governors would appreciate the Trust view on this. Can we see the results for both Lew Trenchard & St Catherine's? We will look into this.

8. Improvement Plan – Review and Data Analysis

This is largely covered in the Heads' Report. LH has prepared a spread sheet that calculates the results and she will make this available to the governors when it is complete. Results won't be available until next week. 9/16 at Lew Trenchard in Y6 are SEN, and Writing attainment is therefore low. Writing at St Catherine's has improved at 83% overall. Both schools are looking good for development with Phonics

at 88/89%. Y2 shows improvements in Writing but this is still low – this is typical throughout all the Trust schools.

9. Curriculum

This is on the website and we have included everything that Ofsted recommended.

10. SIAMS

We had a very positive pre-SIAMS visit but we haven't received the report yet. The church element is featured on our websites. Exeter Diocese is updating their R.E. policy which we will adopt. LH has shared the Truro Diocese forms with the governors and has visited a Cornish school for Pre-SIAMs monitoring.

11. Safeguarding

All governors confirmed they've watched the KCSiE video.

12. Review SEND and Attendance

Attendance is good and approximately in line with the national average.

13. P.E. Review and next academic year plan

The plan will be finalised at the end of the month. MH has completed monitoring visits – see item 19.

14. Staff Matters

Numbers are good in both schools and everything is going well.
